Motion by T. Ables to retain McClure \& Wolf as the CPA firm. Second by B. Nickelow. Motion Carried.

Motion by Jack Stewart seconded by B. Nickelow to continue United Bank and First United as Borough Depositories. Motion carried.

Motion by J. Stewart and seconded by Tyler Ables that the meetings for calendar year 2022 will be the seconded and fourth Mondays beginning in February with the seconded meeting in January to remain on the third Monday. Motion Carried.

Motion by Billie J. Nickelow and seconded by Tyler Ables to appoint the J. Corcoran and J. Stewart as representatives to S.W.R.T.B. Motion carried

Motion by Jack Stewart and seconded by Tyler Ables to retain Harold L Whyel as borough Secretary/Treasurer and to signature authority on checks, to have administrative access over bank accounts, and to have the authority to access the bank accounts and to transfer funds as becomes necessary to conduct borough business. Lastly to remove Martha Ochkie from all bank accounts. Motion carried.

Being no further reorganization business, the President called for adjournment seconded by T. Ables, motioned carried.

President J. Corcoran then opened the first regular meeting of the calendar year.
